IV. Authorization and Waiver of Liability

By signing this form, I agree that I have at least a 2.5 GPA and am not on either scholastic or disciplinary probation. I also agree to fulfill any and all financial and academic obligations to Louisiana State University Agricultural and Mechanical College and others in connection with the Intersession in New York program _____ (initial here).

I understand that failure to fulfill my financial or academic obligations may affect my ability to study on the Intersession in New York program through LSU and/or my academic and enrollment status at LSU. I have read and understand the following program terms, conditions and obligations:

- To maintain eligibility in the program, I must satisfy all spring intersession program admission requirements, including timely payment of all tuition and fees, as described in the program literature. My signature on this document authorizes Academic Programs Abroad to charge the \$500 deposit and program fee to my fee bill. I must fulfill all financial obligations to the Intersession in New York program prior to departure.
- I must enroll in HUEC 3030 in spring intersession and remain in good academic standing while participating in the program. All exceptions must be approved in writing by the Program Director.
- I certify that I am not currently on disciplinary or scholastic probation. Should I be placed on disciplinary or scholastic probation for the academic term in which I will be traveling, I will alert Academic Programs Abroad in writing prior to my departure. I understand that I cannot participate in a spring intersession program while I am on disciplinary or scholastic probation and that I will still be financially responsible for any/all fees incurred by the program on my behalf in the event that I am unable to attend because of disciplinary or academic probation.
- To withdraw from my Intersession in New York program, I will submit a request to withdraw in writing to Academic Programs Abroad. I understand that my \$500 deposit will be non-refundable if I withdraw after November 20, 2009. I understand that my Intersession in New York program must make payments to service providers on my behalf and that these payments may not be refundable. Therefore, I agree to abide by the following payment schedule in the event that I withdraw from the spring break program:

Withdrawal after November 20, 2009:	\$500 deposit will be paid
Withdrawal after January 29, 2010:	\$500 deposit and \$1,000 payment will be paid
Withdrawal after February 15, 2010:	\$500 deposit and entire program fee will be paid

- It is my responsibility to attend all informational meetings concerning my Intersession in New York program. I am responsible for submitting, by the applicable deadline, all forms as required by LSU and/or the Program Director.
- I understand that submitting this application does not guarantee acceptance into the Intersession in New York program, and that I must meet the program requirements listed above and be accepted into the program by Academic Programs Abroad.

I have read and understood this agreement, and I agree to the terms and conditions set forth above. No alteration or variation of this agreement shall be valid unless accepted by LSU in writing.
